Equipment Classification and Qualifications

The U.S. Internal Revenue Service (IRS) is providing consumers with a tax credit on highefficiency water heating equipment under the provisions at Title 26 of the U.S. Code, Section 25C. The Federal tax credit is 30% of the water heater and installation costs up to \$600 for gas-fired water heaters and \$2,000 for heat pump water heaters.

Homeowners must submit <u>IRS Form 5695</u> and meet all federal tax credit requirements to qualify. Tax credit is limited to an existing home and must be the homeowner's primary residence. New construction and rentals do not apply. Any tax credit that exceeds the consumer's regular tax liability for the taxable year may not be refunded nor carried forward under Section 25C. *Please consult with a tax professional for complete details.*


